### II. Explain the relationship between pragmatics and semantics by highlighting the semantic interpretation and the pragmatic interpretation of the following sentence: (5pts) "It is cold in here."

**Semantics** is the study of the **literal and figurative** meanings of words, sentences and expressions, it studies the relationships between the meanings of entities of language, semantics focuses also on the different **layers of meanings** like denotative, connotative, sense and reference meanings.

However, **pragmatics** is the study of meaning within **context**, the context is very important in shaping **hidden** meaning of words, sentences and expressions. The context can be situational (time and place) linguistic and/or cultural

Semantic interpretation of the sentence "it is cold in here" its literal meaning is that the temperature is low in this place

**Pragmatic interpretation** of the same sentence: the speaker suggests to change the place or close the window or switch on the heater
