- Free accommodation in several residence halls for both male and female students.
- **Free transportation** through urban and semi-urban bus services connecting the university with surrounding communities.

The guaranteed national minimum wage (*SNMG*)—set at **20,000 Algerian dinars per month** for a legal working period of **40 hours per week**—is strictly observed. The university maintains detailed salary records confirming adherence to this standard, thereby demonstrating its ongoing commitment to fair remuneration, financial stability, and decent living conditions for all employees.

#### **Recognizing Unions and Labor Rights**

The University of Oum El Bouaghi fully recognizes the rights of its employees to establish and join labor unions, in accordance with Law No. 22-06, which amends and supplements Law No. 90-14 on the exercise of the right to unionize. Freedom of association and collective representation are guaranteed, and regular meetings are organized between university management and union representatives. These interactions foster a climate of dialogue, collaboration, and transparency in all matters concerning staff welfare and institutional governance.

# **Ending Workplace Discrimination**

Since **2009**, the university has enforced a comprehensive policy to eliminate all forms of discrimination in the workplace. This policy, updated in **2023**, prohibits discrimination based on religion, gender, age, or sexual orientation. The **University Charter** reinforces the principles of equality, inclusion, and respect for human dignity, prohibiting any form of hate speech or prejudice. Violations of this policy are subject to disciplinary action, ensuring a work environment founded on mutual respect and equality.

Regular audits and data reviews are carried out to identify potential imbalances. Where disparities are found, corrective actions are promptly implemented to ensure fairness and transparency in compensation.

The growth of spin-offs also underscores the university's expanding role in supporting start-ups derived from academic research, contributing to regional and national economic development.

#### **Research Income from Industry and Commerce**

The university's collaboration with industry and commerce reached new heights in 2024, generating a total research income of 1,743,000,000 DZD. This substantial increase from 1,132,405,211 DZD in 2023 illustrates the university's growing engagement with the private sector and its effectiveness in translating academic research into practical, market-oriented solutions. These partnerships play a vital role in driving innovation and reinforcing the university's contribution to Algeria's knowledge-based economy.

carbon sources such as natural gas and renewable energy.

This monitoring system reflects the university's strategic direction toward energy

efficiency, sustainable management, and contribution to Algeria's national goals of

reducing greenhouse gas emissions.

## 14.2 Educational and Awareness Programs

The university offers specialized programs addressing limnic and lotic ecosystems, water management, and conservation, such as:

- **Bachelor's in Hydrology** focusing on irrigation practices, hydrological systems, and water conservation.
- Master's in Urban Hydrology emphasizing sustainable urban water management.

These programs contribute to national capacity-building by preparing experts capable of implementing sustainable water management practices across Algeria.

### 2. Education and Awareness on Sustainable Fisheries and Aquaculture

Although not located on the coast, the university integrates concepts of **sustainable fisheries management** and **aquatic biodiversity conservation** into its curricula:

- Licence in Ecology and Environment
- Master in Biodiversity and Environment
- *Master in Ecology of Natural Environments*These programs train students to adopt sustainable practices in resource use and environmental protection.

#### 3. Awareness about Overfishing and Destructive Practices

Through its laboratories and outreach programs, the university raises awareness of illegal, unreported, and unregulated (IUU) fishing and its ecological impacts:

 The Functional Ecology and Environment Laboratory (LEFE) conducts workshops and seminars on aquatic conservation.  The Sustainable Development and Environmental Protection Laboratory (LDDPE) promotes environmental stewardship and campaigns against destructive fishing methods.

### 4. Conservation and Sustainable Use of Aquatic Resources

The university conducts field trips and public awareness events to engage students and citizens in conservation activities:

- World Wetlands Day (2023) A field trip to Ourkis Dam was organized in collaboration with the Directorate of Environment, featuring biodiversity education and tree planting.
- **Geological Sciences Symposium (2024)** Focused on sustainable resource management and environmental impacts.

#### 5. Sustainable Sourcing of Aquatic Food Products

The university supports responsible sourcing practices guided by national and international sustainability frameworks, including:

- Law No. 05-12 (2005) permitting treated wastewater for irrigation;
- Executive Decree No. 10-23 (2010) regulating wastewater treatment systems.

#### 9. Plastic Waste Reduction Policy

The university implemented its **Plastic Reduction Policy** in 2010 (reviewed in 2024), which emphasizes:

- Compliance with national environmental legislation;
- Awareness campaigns on plastic pollution;
- Substitution with biodegradable materials;
- Waste reduction and recycling initiatives.
   Collaborating partners include the Ministry of Environment, National Waste Agency, and APOCE.

#### 10. Prevention of Land-Based Marine Pollution

Although located inland, the university enforces an environmental policy targeting pollution originating from terrestrial sources, aligning with the **Algerian Littoral Law** (Law No. 02-02).

It supports research and community projects that minimize pollution runoff into aquatic systems.
