**Problem of the Seminar**

The increasing aggression against the health structures and institutions with sabotage, and against their users a well, through verbal and sometimes physical violence, is considered to be in the midst of the most important repercussions of the spread of the Corona virus pandemic in Algeria, as a result of the great pressure exerted on the health sector, which attempted, despite the shortage of material and human capacity therein, to absorb the large number of disease cases they have been receiving on a daily basis; the fact of which has provoked health users to work in a busy atmosphere, thus exposing them to a variety of aggression forms, in addition to those experienced against the health structures and institutions themselves. Besides, this specific fact of issue imposed the need for legislative intervention in order to ensure greater protection for health institutions and the employees in the health sector, whose voices were raised under such circumstances so as to insist that maximum protection be granted to them; the objective of which was attained by promulgating the Ordinance No. 20/01 dated 30<sup>th</sup> July 2020, amending and supplementing the Penal Code, which has supplemented, through its Article 02, the

Penal Code in its Section 01Bis, entitled: “Outrage and violence against the health institutions and their staff, the fact of which has prompted us to endeavour finding out the content of the Penal Protection guaranteed by Ordinance N°20/01 to health institutions, as well as to health staff and similar staff, during or on the occasion of the exercise of their duties? And what if the legislator had succeeded in eradicating the phenomenon of the acts of aggression on the equipment and property of the health institutions, and the hindrance of their performance, on the one hand, and similar aggressions made against medical staff, on the other hand?

**Objectives of the Seminar**

This Seminar aims to achieve the following objectives

- ✓ Understand the definition of the heath institutions, and presentation of their staff;
- ✓ Understand additions made by the Law No.:20/01 in sentencing the aggressions against the heath institutions and their staff;
- ✓ Identify the efficiency of this modification to put an end to such acts of aggression.

## Themes of the Seminar

**The first theme:** The conceptual framework (definition of the different types of health institutions, and health users and professionals, in pursuance with the Law No.:18/11 dated 18<sup>th</sup> Chaoual 1439, corresponding to 02<sup>nd</sup> July 2018, pertaining to Health...).

**The second theme:** Photos of the attacks on the health institutions and structures (sabotage of real properties and furniture, etc.)

**The third theme:** Photos of the aggressions against health users (insults to health users, violent aggression against health users, breach of professionalism and moral integrity of health users).

**The fourth theme:** Assessment of the Algerian legislator's policy in terms of penal protection of the health institutions and their users.
