#### Forum problematic

Based on the aforementioned, the problematic of the forum arises to clarify theactual reality of the right of access to information and its perspectives, and consequently:

To what extent the right of access to information has been reflected in Algeria's legal system? And what are its prospects given the new changes?

#### **Forum objectives**

The objectives of the forum are:

- Define the parameters of the right of access to information and its concepts,
- Determine its actual reality in Algeria,
- Discern its exercise legal guarantees,
- Highlight some international experiences on the exercise of this right in their comparative laws as a reference inthe structuring of the legal framework of the right of access to information in our country,
- Open a discussion without complexity with academics and participants of all kinds to come up with recommendations and suggestions, which will have a positive and useful impact on the legislator to set aframing law on the exercise's modalities of this constitutional right in Algeria.

#### Forum axes

- Axis 1: Anchoring the right of access to information (conceptual framework).
- Axis 2: Guarantees for the right of access to information's exercise.
- Axis 3: Scope of the right of access to information's exercise.

Axis 4:Fields of application of the right of access to information and its constraints.

Axis 5: Models of international experiences onthe right of access to information's exercise.

#### **Conference theme and Importance:**

The right to access information has conspicuous international significance, being one of the utmost principles and backbonesto the establishment of the State of law and rights, and one of the important pillars of modern democracy foundation, throughout the activation and execution of legal texts to protect human rights, since the values underlying the access to information laws actually are universal values inscribed in the international charts (the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights and the UN Convention against Corruption), as they are embodied in all constitutions of the world, including the Algerian one, in article 51 of the constitutional amendment of 2016, which corresponds to article 55 of the constitutional amendment of 2020, leaving out the modalities of the right of access to information's exercise to the law, which it does not exist yet

The right of access to information means the right of an individual or a citizen to access or obtain information by any legitimate means from the publicauthorities.

This right is regarded as one ofthe moment's top list issue, and indeed is one of the pillars of the promotion of national public opinion and monitoring public bodies, and therefore it creates a relationship between the State and its citizens and also reinforcestrust among them.

Accordingly, in the absence of a legal framework for the exercise of this right in Algeria, and given its importance, emerged the idea of organizing this forum,in order to partake in determining its content and clarifying its limits, and the necessary guarantees for its practice, then pinpointing the bodies entrusted with it, as well as its scope and its appealing procedures, that is whywe wanted to trigger a debate on this particular topic, because of its close relationship to participatory democracy embodiment for citizens to participate in public affairs management, which principally requires access to all information with full transparency, and which will betackled during the forum, by discussing the current situation of this right in Algeria and what is expected in the future, especially given the changes that Algeria has undergone recently, and finally providing recommendations and suggestions to the issue.
