1- Preamble:

The era of openness of electronic space on the free transfer of information and social networks and their used and developed applications constituted an interactive dimension with the public that was absent in other means, which made it possible, in view of the huge amount of information published and circulated through it, to reachlong-termgoals in the depth of impact and impact (psychological, social, media, Religious..., etc.) and the power of direction and the severity of the danger as well. These developments gave rise to fundamental changes in the roles and tasks of many individuals and sectors, thus forming an essential component of the social system, by attracting and receptive to information and for most groups and social classes and in various fields, be they religious, political, Economic media and legal due to its importance in events coverage, exchanging information, consolidating relations and facilitating the performance of many functions through them with the least effort, cost and the shortest possible

Furthermore, the increasing frequency of excessive, momentary, and irrational use of social networks has led to the emergence of many currents warning of the emergence of a real danger to the system of values and information of the individual and society, especially in light of the extensive and unlimited electronic exchange and circulation of many unreliable information on many issues, and addressing it from different angles, making it a complex phenomenon in its digital context, as a result of the overlapping and intertwining of technological, communication, informational and even security dimensions in its industry, which affected in one way or another the free and secure electronic circulation of information,

Moreover, in light of the freedom granted to users and the difficulty of controlling and monitoring the flow of information at the level of those networks, these remarkable developments have led to the emergence of many professional, ethical,

legal, security, economic and political problems in the circulation of that information in its various forms (text, audiovisual, audio, pictorial, symbolic...) such as: the spread of false news and misinformation, unreliable, anonymous and multi-source information. ease of distortion and falsification of content, informational value alienation, propaganda, hateful speech, informational violence, isolation, the need to control content in light of the flow of freedom of communicative information, which led to the recognition of the difficulty of reconciling the private and public interest (outwardly and inwardly) by allowing freedom of access and access to information and its electronic circulation or limiting it at the same time by the management of those networks or other parties in a selective or biased manner to one party at the expense of another party.

The best evidence of this is the adoption by most of the social networks of systems of censorship and restrictions on the content of the information published through them, given the size of the political and economic pressures imposed on them, which made under the pressure of proponents of freedom of information exchange and expression electronically through these networks, and in accordance with what is stipulated in international conventions, and between those who seek to restrict the electronic circulation of information, especially those that contradict the directions of states and pressure groups that have the power to influence social networks.

In this conference, we seek to: examine and address the aforementioned problems, resulting from the overlap of several variables and indicators, which necessitated cooperation between several multidisciplinary theses (legal, social media. religious, security, economic,...) as an attempt to reapparoach critical visions and distinct ideas about social networks and electronic circulation of information to bridge the legal and ethical gaps, and reduce the informational and technical gap in addressing electronic maneuvers and conspiracies, and also establish an electronic communication strategy based on the safe and ethical circulation of information through social networks and in various fields.
