Preamble of the conference

The new Investment Law 22-18 came to outline the modern direction of the investment policy pursued by the Algerian state, where for the first time the legislator is keeping pace with modern economic trends that depend on the balance of interests and the clarification of the objectives set forth in this law, taking into account how benefits and incentives are granted according to a strategy. With the aim of achieving sustainable and balanced economic development.

The problem that must be addressed is: How effective is the investment policy pursued by the Algerian legislator to achieve the requirements of sustainable development?

Objectives of the topic: We aim, through research into the topic "Modern trends in investment policy in Algeria - towards achieving the requirements of sustainable development." To achieve a number of goals, the most important of which are:

- Highlighting the most important modern policy trends to regulate the investment process in Algeria and the innovative guarantees provided by the legislator that contribute to encouraging and attracting investors, in addition to the incentive systems and the new role of the agencies in charge of the investment process, especially after the creation of the digital platform for the investor.
